# Terms & Conditions & Customer Service Policy

## 1. Office Hours & Order Placement

Office & Warehouse: Monday to Friday, 8:00 AM – 5:00 PM

## 2. Delivery Options & Charges

Own Van Deliveries:

- Within M25: Minimum order £80, surcharge £10

Courier Deliveries:

- Parcel (Ambient):
  - Minimum order £120
  - £15 surcharge for orders £120 – £200
  - £10 surcharge for orders £200 – £300
  - Free for orders £300 – £500
- Pallet (Chilled/Ambient):
  - Minimum order £600
  - £40 surcharge for orders £600 – £800
  - Free for orders above £800

Note: High-volume items incur a £5/box surcharge. Glass and selected items cannot be sent via parcel.

## 3. Availability & Pricing

All goods are subject to availability and price fluctuations.

Prices are exclusive of VAT, charged at the prevailing rate.

Prices may change without notice.

## 4. Payment Terms

Standard Terms: 30 calendar days from invoice date (for approved credit accounts).

Accepted Payment Methods:

- Card
- Online via Sage “Pay Now”
- Bank transfer
- Direct Debit
- Standing Order

Buyers must request and retain proof of payment.

No dispatch while overdue balances remain.

Credit facilities may be revoked without notice.

## 5. Delivery Conditions

Risk passes to the buyer upon delivery or collection.

Damage in Transit:

- Must be reported by phone on the day of delivery and confirmed in writing within 3 days
- Claims must comply with carrier’s terms

Returns:

- Accepted only for legitimate faults in product or packaging
- Damage due to buyer negligence is not eligible for credit
- Chilled/frozen goods cannot be returned once signed for

Incorrect Delivery Info: buyer is responsible; re-delivery charges may apply.

## 6. Claims & Liability

No liability for indirect or consequential loss, except where required by law.

Buyer shall indemnify the seller against third-party claims arising from goods sold.

## 7. Title of Goods

Legal title remains with the seller until full payment is received.

Seller may recover goods from buyer’s premises in case of non-payment.

Returned stock to settle accounts will be assessed based on resale potential.

Credit facilities may be withdrawn at any time without notice.

## 8. Force Majeure

Seller is not liable for delays or failure to fulfil obligations due to circumstances beyond its control.

## 9. Governing Law

All contracts are governed by the laws of England and Wales.
